IMPORTANT INFORMATION ABOUT ESTABLISHING A RELATIONSHIP WITH DOOSAN INFRACORE FINANCIAL SOLUTIONS, A BUSINESS UNIT OF DOOSAN INFRACORE INTERNATIONAL, INC.

In compliance with the principles of the "Proceeds of Crime (Money Laundering) and Terrorist Financing Act (Canada)", the policies of Doosan Infracore International, Inc. and its business unit Doosan Infracore Financial Solutions, including our agents, affiliates and third party service providers, third party financiers, and any of our designees (collectively "Doosan") require us to obtain, verify, and record information that identifies each person or business that opens an account or establishes a relationship with us. What this means for you: when you open an account or establish a relationship with us we will ask for documentation showing your name, address, date of birth and government issued identification numbers (such as your Social Insurance Number ("SIN") (optional), driver's license number (optional) or your valid Canadian Passport, a Certificate of Canadian Citizenship, a Certificate of Naturalization with a photograph, a permanent resident card with a photograph, or a Provincial Health Insurance Card). As indicated above, the provision of your SIN is optional and the processing of the application or guarantee is not conditional on you providing your SIN. However, choosing not to provide your SIN is likely to increase the time required to process the application and may result in Doosan not receiving accurate information about your credit rating. For businesses, we will ask for the business name, street address, articles of incorporation or a government issued business license, GST number, or registration number and we may ask for certain information to identify the signing officers of the business.

CONSENT RELATING TO PERSONAL INFORMATION

TO: Doosan and their affiliates, successors and assigns (collectively, "you") In connection with the request for financing made by [client name] _____ ("Client") with Doosan ("Request"):

- a) I certify that, as representative of the Client (if applicable), I am duly authorized to act on behalf of the Client in submitting the Request and, should a decision be made to do so, to continue the process with you.
b) I represent that all the information, including all personal information ("Personal Information"), which is provided by me in connection with the Request and may in the future be provided to you for the purposes of processing the Request and any future requests of Client and/or me and of completing, servicing and enforcing any resulting transactions (if approved and executed) is and will be true, complete and accurate, and will be relied upon by you to determine the Client's and my eligibility for the financing requested.
c) I represent that the financing requested in the Request is for business purposes only and not for personal, family, household or farming purposes.
d) I consent and authorize you, your agents, assigns, contractors, employees and representatives:
i) to investigate and/or verify all credit, financial and other information about the Client and me including Personal Information and information related to our credit rating, financial capacity and payment history (collectively, "Information"), and to collect, use, communicate and disclose (collectively "share") Information among yourselves and with credit reporting agencies, financial institutions, creditors, vendors and other outside sources, within or outside Canada, as you deem necessary for the purposes of processing the Request and any future requests of Client and/or me and of completing, servicing and enforcing any resulting transactions (if approved and executed);
ii) from time to time during the Client's and my course of dealing with you, in the future to make further investigations and verifications of the nature described herein and further share Information for the purposes described herein; and
iii) from time to time (including after termination of the Client's and my dealings with you), to respond to inquiries from, and exchange any Information with, third parties (including credit reporting agencies, financial institutions, creditors, vendors and other persons) concerning our credit rating, financial capacity and payment history or as required by law.
e) I acknowledge that you have a direct business requirement for the Information in connection with a business transaction or a credit transaction involving me or respecting me;
f) I further consent and authorize you, your agents, successors, assigns, contractors, employees and representatives to share the Information (including Personal Information) among yourselves and with third parties from time to time in order:
i) to improve and develop your existing and additional products and services;
ii) to conduct surveys to better understand the needs, profiles and experience of your customers, except that I may ask Doosan at any time not to use or share Information for such purpose by calling my Client's Financial Sales Manager ("FSM") at Doosan;
